REGARDING HARRY vied inside a pair of rivals, lost a bit of ground early on the backstretch then moved up to challenge again, fought from the fence through the far turn, dug in down the lane, led into deep stretch and held gamely. PROBLEM SOLVER stalked along the inside then two wide around the first turn, angled out on the second bend, took aim four wide entering the lane, challenged from outside and could not summon the needed final kick. PIO NONO raced along the inside and had to take hold a bit running on heels into the first turn, reserved after in the early going, followed patiently from the fence then two wide on the far turn, angled out in the stretch and gained third. ROCKSALOT vied between rivals, battled down the lane and weakened late. SWEET KNOWLEDGE was off slow to begin, traveled four wide through the first turn, remained wide up the backstretch, moved into the three path on the far turn, came back out to the four path late on the bend, tipped out at the top of the stretch and failed to threaten. MAXVILLE vied three deep to midstretch and weakened in the furlong grounds. LEGAL MOUSSE broke a step slow, chased keenly while a bit rank in the three path on the first turn, stalked four wide into the second bend, came five wide into the stretch and tired.
