## Footnotes | View Glossary Of Terms

TEE N OFF vied inside a trio of rivals to the turn, dueled with FAR OVER LOADED around the bend, cleared into the stretch, drew away under right-handed urging, switched to the left-hand at the eighth pole and remained clear to the wire. BET THE OM raced up close five deep, moved into the four path on the turn, tipped back out and came six wide into the lane, rallied into second past the eighth pole but failed to threaten the winner. CANCUN NATIVE was off slow to begin, lagged behind early, went three wide into the turn, angled out and came seven wide into the stretch, finished well from the middle portion of the track and missed second. CROWN PROSECUTOR chased outside a rival into the turn, remained two wide into the lane, altered out in upper stretch, altered again midstretch and kept on to round out the superfecta. NAVAL HARBOR vied three deep between up the backstretch, remained close through the turn, came four wide into the lane and flattened out in the furlong grounds. FAR OVER LOADED coaxed along early fighting for the lead between rivals, dueled around the turn, lost touch with the winner three wide entering the lane and also flattened. KING ZOG vied four deep up the backstretch, four to five wide on the turn and weakened. BANKIN ON JONATHAN stalked the speed battle from inside, saved ground to the stretch and weakened.
