RO TOWN dueled from inside up the backstretch and around the turn, shook free at the three-sixteenths pole and remained well clear to the wire. MANIAE chased along the inside, bumped repeatedly with outer rival early on the turn, continued to save ground to the stretch, then finished well to gain second. A REAL JEWEL chased three deep early, moved into the two path on the turn, kept on down the lane but lost second late. PERFECT LIFE chased from off the pace early on, rounded the bend three then four wide and failed to respond. MIRACLE BALL chased four deep up the backstretch, stayed well off the rail to the stretch and lacked a bid. RYAN'S GIRL chased after the top pair between rivals, bumped repeatedly with MANIAE early on the bend, tipped out into the lane, angled out further in the drive and weakened. BIG CELEBRATION chased widest up the backstretch, came six wide into the lane and was never a factor. CHARMED DREAM dueled from outside to the stretch, yielded to the winner at the three-sixteenths pole and folded in the final furlong. DISCREPANCY chased from inside, ducked out into the turn and unseated the rider, ran through the outer fence and was transported off the track via equine ambulance. THERE WAS A STEWARDS' INQUIRY INVOLVING THE INCIDENT WITH DESCREPANCY INTO THE TURN AND RULED THAT SHE CAUSED HER OWN PROBLEMS AND WOULD BE NO CHANGE.
