## Footnotes | View Glossary Of Terms

HONEY BUCKET bumped leaving the gate, chased from inside, lugged out into the turn to bother DESPITE, bid between at the five-sixteenths pole, cleared in upper stretch, then drew away in the final sixteenth. JOYFUL MISCHIEF angled to the inside trailing the field, passed a rival on the turn while saving ground, angled out in upper stretch, loomed at the eighth pole but flattened out in deep stretch. COTE BLANC stepped to the front from inside, took pressure around the turn, yielded in upper stretch, weakened in the final furlong but was able to hold third. GRAINNE O'MALLEY bumped at the start, raced up close in the early going, bid from outside on the turn, bore out badly at the five-sixteenths pole, churned on down the lane and earned minor award. TIGER OF THE SEA stumbled badly in the beginning, chased three deep into the turn, got carried wide late on the turn and weakened. DESPITE chased between rivals approaching the turn, got squeezed and took up at the seven-sixteenths pole, dropped back to last shortly after and failed to recover. THERE WAS A DOUBLE INQUIRY IN RACE THREE. THE FIRST INQUIRY INVOLVED HONEY BUCKET AND DESPITE AT THE SEVEN-SIXTEENTHS POLE. THE STEWARDS UNANIMOUSLY RULED THAT ALTHOUGH HONEY BUCKET DID LUG OUT AND CAUSE DESPITE TO TAKE UP, THE INCIDENT DID NOT WARRANT A DISQUALIFICATION. THE SECOND INQUIRY INVOLVED GRAINNE O'MALLEY AND TIGER OF THE SEA AT THE FIVE-SIXTEENTHS POLE. FOLLOWING A REVIEW, THE STEWARDS UNANIMOUSLY RULED TO DISQUALIFY GRAINNE O'MALLEY FROM FOURTH TO FIFTH FOR BEARING OUT BADLY, FORCING TIGER OF THE SEA WIDE AND COST THAT RIVAL A CHANCE AT A BETTER PLACING.
