## Footnotes | View Glossary Of Terms

RAGING WATERS bumped leaving the gate, stalked between early, followed behind the leaders in the two path on the turn, tipped out at the top of the lane to launch a bid, challenged three deep at the three-sixteenths pole, cleared into the furlong grounds and won going away. BLUEGRASS GO GO pressed from outside, dueled around the turn, led between at the three-sixteenths pole, lost command shortly after and stayed on to secure second. WINDS OF FREEDOM showed the way while under pressure up the backstretch, fought head to head around the bend, lost command to BLUEGRASS GO GO, fought to midstretch, weakened in the late stages but was able to save third. GREAT KING (FR) chased four deep to the turn, three deep around the bend, bid four deep entering the lane and flattened in the final furlong. PANUCO bumped leaving the gate, stalked along the rail, lost positions around the turn and could not rally. ALPINE THUNDER chased out of range well off the rail, entered the lane four to five wide and lacked a rally. YOGI BOY chased three deep between runners, continued between foes on the turn, bid three deep exiting the bend and weakened. CAROL'S COMIC settled widest in the early stages, went four wide int othe turn, chased five to six wide into the lane and was never a factor.
