TWICE GOLD, in hand in the two path between horses stalking the pace around the turn, bumped with DATS MY PHARAOH entering the stretch, took the lead outside RETURN FIRE near the eighth pole and drove clear. DATS MY PHARAOH hugged the inner rail in a forward position around the turn, bumped with the winner while in close quarters along the rail, swung out near the eighth pole and rallied. RETURN FIRE made the early lead and was taken to the inner rail, remained along the rail, set the pace to the eighth pole and weakened late. MAUPANSANT, four wide on the turn, floated out in upper stretch and lacked the needed rally. SALVO TRIGGER raced in the three path on the turn, worked between horses in the stretch and failed to rally. RIGHT OF RUSH stayed along the inner rail on the turn, angled out, raced between horses in the stretch and gave way. UNCLE GREY was outrun. THIRTY WEST prompted the pace two wide on the turn, moved to the three path entering the stretch and gave way. AMERICAN LITIGATOR stumbled badly leaving the starting gate, dropped back leaving the turn. An objection by the rider of DATS MY PHARAOH against the winner was not allowed.
