IN MY MEMORIES prompted the pace outside TALK TO THE JUDGE, wrested command entering the stretch and drew clear under vigorous rousing. ITSAMONSTAMASH raced in the two path between horses on the turn, remained in the two path in the stretch and rallied. TALK TO THE JUDGE accelerated to the lead, set a pressured pace along the rail, failed to keep pace in the stretch and weakened. KILO ROAD trailed to the stretch, hugged the inner rail and rallied. BACK FORTY , four deep on the turn, was no factor. GREEN EYED MONSTER , three deep on the turn, chased the pace to the stretch, drifted out and gave way. MY FLICKER remained along the inner rail on the turn angled out in upper stretch and weakened.
