WILD VINE broke forwardly despite a bobble, stalked two to three wide under a light hold early on, responded when ridden along past the half, went on an outside attack past the three eighths, secured command soon into the lane, eagerly kicked away under a drive in mid stretch then maintained a comfortable advantage while steadily hand ridden the final seventy yards. QUICK TO ACCUSE cleared early and set the pace towards the inside, was joined mid turn, dueled into the lane, proved no match heading to the furlong grounds but dug in gamely to preserve the place. WORCESTER rated four wide outside runners, advanced four wide under a ride into the stretch, chased while on his left lead and churned on. WYNSTOCK , two wide pursuing, raced between runners in upper stretch, shifted in but came up empty. DUKE OF GLOUCESTER , three wide within stalking distance leaving the far turn, was under a hearty ride mid turn, toiled between rivals in mid stretch then faded. FULMINEO lagged off the pace, raced five wide in upper stretch but failed to generate a serious finish. SEVEN'S ELEVEN was rated back between foes early, angled in, lacked a punch around the turn and faded. CAP COM , between rivals early, was under pressure past the half and weakened.
