OBAN reserved in mid-pack racing between rivals down the backside, rallied on the far turn angling to the inside, collared the pacesetter in mid-stretch and drew off in the final sixteenth. COASTAL WARRIOR raced up from the outside gate to take the lead on the first turn three wide, opened a clear lead on a well rated pace for three-quarters, had no answer for the winner when challenged and ran-on as second best. FOOLISH MORTAL unhurried to be the trailer for the first half mile, picked up his pace into the far turn and made a steady bid to be gaining late. BRAVITAS raced near the rear of the field to the head of the stretch and showed good interest in the lane to hit the board. I AM ON THE LIST stalked the pace for five-eighths and lacked a response when called upon on the turn. ENDUE raced in the back half of the field through the first turn, moved up five wide into contention down the backside, was well place in striking distance turning for home from four wide and flattened out in the lane. CINCO TACO failed to menace. MCGINNIS prompted the pace for a half and came up empty entering the final turn. THE RACE WAS HAND TIMED DUE TO AN EQUIPMENT MALFUNCTION.
