CHOSEN JUDGE (IRE) rated, rallied, edged clear, led over the final hurdle, hand ridden out through the stretch. DANTE'S FIRE stalked in second, chased leader into last fence and to the wire but could not gain. ARTISTIC CHOICE (IRE) stalked in third, rallied on rail, weakened in the final strides. L'AVVOCATO (FR) rated, traveled evenly and had no late response. GARRISON FOREST (IRE) sent off to a clear lead, stopped before the final fence and was eased.
