BONITA VIDA set the pace drawing off in upper stretch winning as much the best. FEISTY MAMA chased the pace being dispatched by the winner in upper stretch holding up for place. CATRINA ZAR slow early rallied in upper stretch coming out a touch bumping foe near the sixteenth pole continuing on to finish well. LAST CALL JENNA slow early lost ground to upper stretch giving a mild rally being crowded late. LA PACIFICA racing evenly was bumped near the sixteenth pole posing no late menace. ROCKIN' LIONESS was never involved. AN OBECTION FROM THE RIDER OF LA PACIFICA AGAINST THE RIDER OF CATRINA ZAR FOR INTERFERENCE NEAR THE SIXTEENTH POLE WAS DISMISSED BY THE STEWARDS.
