POST FACTO slow early lost ground to upper stretch coming with a wide rush arriving in time. COURTHOUSE COVE pressed the pace shaking clear in upper stretch being run down at the wire. PROBALE TEN raced evenly vying willingly from mid track down the lane. COST BASIS raced evenly through the turn vying inside down the lane. ALFIE SOLOMONS chased the pace to upper stretch weakening late. R DOC played no factor. READY FOR ACTION was never involved. HOUSEBUILDER weakened on the turn. ONE LAST KISS was always outrun. BURTON WAY pressed through the turn wilting in upper stretch.
