BAILEY'S GIRL gave a quick advance on the far turn looming in upper stretch moving clear abreast foe. SPERRY CHALET gave a quick middle move to clear into the far turn being hooked from the outside late ceding grudgingly. CRAFTY LAWYER gave a middle move racing five wide to upper stretch vying willingly late at mid track. GORDA stalked the pace threatening in upper stretch coming up short in the four path. MAZARN stalked the pace then weakened in upper stretch. ELEKTRA KING raced evenly needing more along the inside. COME A WALTZING gave a middle move then faded to upper stretch. CITIZENS QUEEN played no factor. ALGEBRAINTHEDARK led early then gave way abruptly nearing the far turn.
