MY DANIELA dueled to stretch weakening late. UNA ROCA was never involved. BLACK BETY pressed the pace tiring late. AN OBJECTION FROM THE RIDER OF AURORA'S MUSIC AGAINST THE RIDER OF MY LUCKY DELA FOR INTERFERENCE IN THE STRETCH RUN WAS DISALLOWED.
