DEMBE ZUMA lost ground to upper stretch surging clear six wide. SPUNS KITTEN pressed the pace dueling into upper stretch ceding late to wide pressure. PRINCE JEREMY pressed the pace dueling to upper stretch weakening late. GIACOMO CASANOVA chased through the turn finishing evenly. UNION BRANCH played no factor. PARK AVE PRINCE was always outrun.
