CAPTAIN CREED set the pace coming under pressure to upper stretch turning away a pair of rivals in determined fashion. ROGUE ELEMENT rallied into the final turn bidding six wide down the lane pressing to the wire. TRIPLE START gave a middle move drawing even abreast rival into upper stretch before faltering late. SILVER FRONT stalked the pace dropping off to the final turn regrouping to finish well along the inside. FORT LANGLEY stalked the pace pressing in bid to upper stretch weakening late. OPRY gave a middle move then faded to upper stretch. This race had a timing discrepancy or malfunction and was re-timed using video technology to arrive at the most accurate time.
