ONE ANNIE stalked to upper stretch rallying clear late. TAMMY'S CRUISER tracked evenly to upper stretch saving place at mid track. GO GO STAR set a clear pace to upper stretch weakening late. IMPETUS ECHO (GB) slow early lagged to lane moving up late. ELOPER was checked between horses in upper stretch. REVOCATA played no factor. WIDERTHANAMILE faded in upper stretch. GOSPEL EXPRESSION was never involved.
