TOM AND JAZZY slow early hit stride surging into upper stretch drawing clear under a drive. CASH CUSTOMER sent hard set the pace being hooked from the outside in upper stretch drifting a bit brushing with foe near the eighth pole weakening late. ALFIE SOLOMONS pressed in upper stretch being put in close quarters past the eighth pole angling inside weakening late. ALL THE WAY slow early saved ground to upper stretch improving some there. BAZOO was never involved. EMPEROROFTHEDARK pressed the pace to mid turn ceding there wilting into upper stretch. AN OBJECTION FROM THE RIDER OF ALFIE SOLOMONS AGAINST THE RIDER OF CASH CUSTOMER FOR INTERFERENCE IN THE STRETCH RUN WAS DISMISSED BY THE STEWARDS.
