## Footnotes | View Glossary Of Terms

MISTERCHILLIWILLI set a pressured pace clearing in upper stretch holding firm along the inside. SEVEN CHANNELS slow early angled out in upper stretch rallying four deep to save place. GHOSTLYPRINCE saved ground vying from the rail down the stretch needing more at the end. ATTA BOY ANTHONY pressed then chased to upper stretch weakening late. TAP EM gave a middle move vying from the inside in upper stretch weakening late. OVERBORE stalked the pace weakening in upper stretch.
