FOX CREEK pressed on the turn extending into upper stretch proving no match for the winner while securing place. NOBLE SOUL set a pressured pace weakening in upper stretch. MR ENTERTAINER unruly loading delayed the start, rushed throughout pressed through the turn tiring in upper stretch. K J HIGH COUNTRY faded on the turn.
