A OK sent clear set the pace widening a bit in upper stretch holding firm to wire. MR. CARDENAS threatened on the turn chasing through the lane proving a willing second best. RUNSLIKELIGHTNING raced evenly holding the others. LEFT HIM BEHIND chased the pace drawing closer on the turn weakening in upper stretch. CANDY FOR CYNTHIA was bumped and jostled at the break. OCATA was never involved. TEAM MISCHIEVOUS flashed early speed then gave way on the turn.
