BOGEY'S IMAGE set a slow pace with a clear lead throughout, drew off in the stretch, disqualified for weighing in one pound under prescribed weight. UCO VALLEY (IRE) always close, gained second on the final turn and held second to the wire being no match for the winner. ANIMAL KINGSTON settled held up in the rear, stayed on for third. THE BUTLER YATES (IRE) tracked the leader in second, then weakened in the stretch. ROAD TO OZ raced in touch till the final turn, then weakened and passed. BOB'S BAR (IRE) got round and had no rally.
