DEE'S ON DOW stumbled badly at the start, but quickly recovered to set the pace on the inside, dueled inside on the turn, battled heads apart with L'ECLAIR passing the furlong marker, kept a small edge and maintained it to the wire. L'ECLAIR stalked outside a rival in the early stages, moved up entering the turn, bid two wide, dueled into the stretch, dug in gamely outside of the winner through the final furlong but could not get by. SOUTHERN LADY bobbed at the break, tracked on the inside, chased on the turn and tired.
