CITIZEN outrun down the backside, took aim six wide through the lane, shuffled off drifting rivals in deep stretch, steered gained momentum rallied in time to claim victory. SOUPERSILVERDOLLAR stalked the pace around the first turn, with ease took control of the tempo into the far turn, shook free from outside foe leaving the three eighths marker, under heavy urging drifted out leaving the furlong marker, straitened up quickly, dug in gamely, nailed at the wire. VALID CONNECTION brushed the gate broke very slow, advanced out side rivals into the far turn, chased eight deep into the lane, slowly worked inside through the final furlong, finished willingly for the show. ACTION MAN tracked off the pace five wide down the backside, called into action six wide leaving the quarter pole, lost path steadied off drifting pace setter nearing the furlong marker, bid evened out after a troubled trip. PHOTO HOP saved ground well off the pace, never factored through the stretch. COCKTAILS AT NOON away in good order, quickened stride prompted the pace four wide into the second bend, under pressure leaving the quarter pole, gave way through the lane. TIE BREAKER LENNIE broke sharp, set the pace around the first turn, collared leaving the half mile marker, faltered through the stretch. STEWARSD INQUIRY AND JOCKEY'S OBJECT IN THIS RACE, THE RIDER OF ACTIONMAN CLAIMED FOUL AGAINST THE RIDER OF SOUPERSILVERDOLLAR FOR INTERFERENCE THROUGH THE STRETCH, AFTER THE JUDGE'S REVIEW THE RESULT STOOD OFFICIAL NO CHANGE.
