MR. FREDERICKSON reserved off the pace to midway on the turn, rallied four wide to be gaining in the lane, lugged in considerably putting FAST TALKING MAN in tight along the fence and outgamed that one for the place. FAST TALKIN MAN broke inward to be slow from the gate, raced up the inside into contention in the first quarter to be well placed, continued to save ground with a ril trip while in a bit tight in the lane and just missed the place in a troubled trip. BLUSTERING BREEZE trailed to the head of the stretch and passed weaker rivals in the lane. NERO RAY went evenly while traveling wide throughout. RUFUS flashed speed to be the leader to misway on the turn while racing well off the rail and came up empty turning for home.

SHAKE THE FROST broke a step tardy from the gate, raced up between rivals in tight quarters on the first turn to take the lead onto the backstretch, opened a clear lead while well rated to midway on the far turn, responded when called upon to kick away in upper stretch and was never threatened in the lane. REIGNING DREAM was hard held on the lead through the first turn, settled off the pace to stalk down the backside, lost position on the far turn and came on again in the lane to gain the place. IRONCLAD ALIBI reserved off the pace for the first half mile, rushed up the inside into the final bend to loom on the turn and flattened out in the stretch unable to sustain the bid. ORFANO trailed to the far turn, raced along the rail saving ground to no avail and was never a threat. COLOR BEARER tracked the leaders down the backside and came up empty on the final bend.
