GENERAL GINNY chased behind the pacesetter in the two path, was roused passing the three-eighths pole, kicked on inside of rivals from the two path to take a narrow lead passing the furlong grounds, then drew clear. DIVINE MARTHA stalked the pacesetter from the three path, chased under a ride in the four path around the turn, kept on in the five path down the stretch to bid passing the eighth pole, but got out-kicked by the inner winner second best. D' KITTEN raced off the pace between foes in the three path, continued under a drive around the turn, and stayed on down the lane to get up for show late. TAKING CHARGE DESI tracked an inner duo from the four path, was ridden around the turn, but finished on one pace from the six path down the stretch to just miss show. ALA TURKA was wellback in the five path, pushed along in the four path around the turn, but lacked a final bid from the six path in the stretch. SUMMER SNOW set a clear uncontested pace in the two path, received a right handed cue in the three path midway around the turn, but yielded between foes from the four path passing the furlong grounds.
