DAME MAUDE CHARDIN drifted out a bit when clearing into the first turn, corrected and set a rated pace two wide, moved away without much asking past the five sixteenths, widened the advantage after being roused in upper stretch, was kept alert to about the sixteenth marker then cruised home from there. STAR ELLA drifted out some nearing the first turn, drafted back off the pace and settled, angled out near the far turn, circled rivals four to five wide into the lane and continued willingly while second best. MY FINE AQUILINE, floated four wide into the first turn, moved up wide entering the backstretch and chased outside a rival, was under pressure between runners past the five sixteenths, churned on and nabbed the show between foes. HOLIDAY LIGHTS, lightly steadied when in close approaching the first turn, rated back and settled in range while in the clear, advanced three wide after being called upon past the half, pursued to upper stretch then one paced late. SHIPSHEWANA prompted the pace while saving ground, was pushed along to the inside of rivals around the final turn and faded. There was a stewards' inquiry into the run into the first turn. No action was deemed necessary.
