SO DIALED IN roused to the front to set the pace with a clear lead down the backstretch then drew off on the turn and lasted. ALL MY LIFE settled in the middle of the pace while saving ground down the backstretch then angled out to be three wide near the quarter pole and showed his best strides late to gain on the leader and proved clearly second best. SUCCESSION GOLD prompted the pace around the first turn then chased the leader from two wide to the top of the stretch drifted in to bump with rival near the sixteenth pole and made a late push to save the show. BOLDNESS rushed away to settle off the pace while saving ground to midway down the backstretch then fell back slightly but made a mild rail bid in the stretch, bumped with rival near the sixteenth pole but was empty. WILL E SUTTON was allowed to settle at the back to the top of the stretch and passed a tired one. ANDY CANT raced in the middle of the pack while racing two wide down the backstretch, raced three wide on the turn but failed to menace. THE JOCKEY OF BOLDNESS CLAIMED FOUL AGAINST SUCCESSION GOLD FOR ALLEDGED INTERFERENCE IN THE STRETCH RUN, AFTER A STWEARDS REVIEW THE CLAIM OF FOUL WAS DISALLOWED AND NO ACTION WAS TAKEN.
