MISCREANT tracked the early pace three wide, well placed into the turn, set down into upper stretch, vied for the lead into the final sixteenth, took command into deep stretch then edged away late to prove best. RED DELICIOUS ceded the early lead to RUBY RIVER then pressed that rival into the turn, disputed moderate fractions to the quarter pole, vied for the lead between rivals into the stretch, was outkicked in the final sixteenth and held well late for the place. RUBY RIVER hopped at the start and was off a step slowly, sent for the early lead, set a pressured pace to the turn, carved out moderate fractions heading to the quarter pole, dug in while under pressure into upper stretch, yielded to the top pair into the final sixteenth and was a clear third. GOOD ENOUGH FOR ME rated early, saved ground into the turn, swung out while trailing into the stretch and could not muster the needed late response.
