VINNY AND LEO settled three to four wide into the first turn, well placed up the backstretch, loomed three to four wide nearing the quarter marker, confronted SUDDEN SHIFT to upper stretch and battled that rival to the furlong pole, shook free past mid-stretch, drew off while in hand into the final sixteenth and won as much the best. SUDDEN SHIFT settled just behind the early leader and saved ground into the first turn, tracked the pace from the inside into the backstretch, angled three wide to the far turn then bid nearing the quarter pole, led to upper stretch then was overtaken by VINNY AND LEO past the three-sixteenths, battled that rival to mid-stretch, could not keep pace with the winner into the final sixteenth and held safely in the end for second. TURNSANDCONDITIONS settled outside of rivals into the first turn, tracked four to five wide along the backstretch, chased to the quarter pole and spun four wide for the stretch drive, could not muster the needed final response but ran on into deep stretch and got in time for the show honors. HARVARD was forwardly placed early on while between rivals, stalked the pace two to three wide to the backstretch then vied for the lead nearing the half-mile marker, dueled RUNAWAY HARRY into the far turn, was overtaken at the quarter marker and chased to upper stretch, weakened in the final furlong and was nailed on the wire for third. ROYAL DRAGOON was unhurried in the early going, trailed to the half-mile marker, roused two to three wide to upper stretch, needed more in the lane and passed tiring rivals in final furlong. RUNAWAY HARRY was hustled for the early lead, assumed command and set the pace to the first turn, showed the way into the backstretch then met the bid of HARVARD at the half-mile marker, dueled that rival into the far turn, took up nearing the quarter marker, lost position to upper stretch and tired in the drive. LONG SHORTS allowed to settle early on, saved ground along the backstretch then into the far turn, could not muster the needed response to upper stretch and did not factor late. THERE WAS A STEWARDS' INQUIRY INTO THE ACTIONS OF RUNAWAY HARRY ON THE FAR TURN. THE STEWARDS TOOK NO ACTION BASED ON THAT INCIDENT AND RULED THERE WOULD BE NO CHANGE.
