A VAN ON THE RUN tracked the early pace five wide, surged past rivals late in the stretch to be up late. MAN'S CHOICE tracked the pace four wide, rallied late but needed more. SHOWTIME BOY vied for the early lead on the inside, took sole command exiting the turn, nailed by driving rivals late in the stretch. LEROYISALAGNIAPPE vied for command three wide, backed off behind the pace entering the stretch and was held at bay. DOUBLE AGENT raced off the pace, saved ground through the turn but flattened out in the stretch. HARSH TRUTH trailed shortly after the start, passed retreating foe late in the stretch. RAMBLER vied for command between rivals, retreated in the final quarter.
