REMEMBER ME leaned out at the start, vied for the lead with an outer rival while in the two path, drew clear leaving the quarter pole then lasted safely. MALI BALI laid off of the pace in the two path, shifted out to the four path in upper stretch, rallied between horses to duel for place with an inner rival through the final sixteenth and prevailed while gaining on the clear leader. PRINCESSOFTHENORTH broke a step slow and got subtly floated out at the start, lacked speed along the inside, rallied to split foes two wide at the sixteenth pole, sparred for place with an outer foe while gaining late and missed place at the wire. LIVING IN STYLE pursued from midpack in the three path, tucked to the inside nearing the lane, ran on to vie for place into the final sixteenth but got outkicked. AMERICAN OF COURSE bumped with an inner foe at the start, stalked from the five path, floated to the six path in upper stretch, got outkicked by inner rivals and sustained pursuit. GRACE AND GLORY vied for the lead outside of the eventual winner while being kept in the four path, but gave way leaving the quarter pole. RENO TOUCH stalked along the inside, shifted to the three path to chase into upper stretch then faded between horses. HEART LIGHT bumped with an inner foe at the start, lacked speed in the three path and made little impact. CHIPOTLE PEPPER was bumped by an outer rival at the start, tracked in the three path and weakened. COUNTRYCLUB COUPLE was bumped by an outer rival leaving the gate, pursued from midpack in the six path then faded after being floated to the eight path into the lane.
