TALL GIRL stalked in the three path, bid around the far turn, led from the four path turning into the lane, kicked on while drifting inwards, and drew clear in the final furlong. DIVINE CROSS set the pace in the two path, was cued passing the three-eighths pole, lost the lead entering the stretch, fought on from the three path down the stretch, had to steady and alter out passing the eighth pole, and was second best. ELIKA raced up close in the three path, was driven from the two path around the far turn, angled out to the five path at the top of the lane, but faded. TEAM MOM NOT BRUH trailed in the four path early and was never a threat. TRAUMARAMA tracked in the two path early but retreated. YEHAWMEMAW was wellback in the two path but never menaced. AFTER AN OBJECTION LODGED BY THE RIDER OF DIVINE CROSS AGAINST THE RIDER OF TALL GIRL FOR INTERFERENCE IN THE STRETCH, TALL GIRL WAS DISQUALIFIED FROM FIRST AND PLACED SECOND FOR DRIFTING INTO THE PATH OF DIVINE CROSS AROUND THE EIGHTH POLE CAUSING THE FOE TO HAVE TO STEADY.
