PANTHERA'S FATE showed the way near the inside, dueled with an outer bidder around the far turn then drew clear in upper stretch. COLONEL POPPY settled off of the pace along the inside, rallied between horses into the final furlong, bid for place and dueled with an outer rival through the final sixteenth, then narrowly prevailed. POPPY'S PRIDE stalked three wide, pressed two wide at the five furlong pole, dueled outside of the eventual winner while kept in the three path around the far turn, yielded to that one in upper stretch then missed place to an inner foe. SHIVAREE raced close up in the three path, chased down the backstretch, moved out to the four to five path in upper stretch and sustained pursuit evenly. TOAST TO COAST broke a beat slow, pursued from midpack two wide and between horses, then in the four path turning for home, floated out to the five to six path while chasing in upper stretch but lacked progress. VINNY AND LEO tracked along the inside, chased into the lane and yielded. DIGITAL FOOTPRINT lacked speed in the three path and failed to factor. BOBBY'S GIFT tracked in the four path then faded in the five path rounding the far turn. SUDDEN SHIFT dwelt and spotted the rest multiple lengths at the start, tugged closer in the five path around the first turn, chased then weakened in the six path turning for home. TURNSANDCONDITIONS trailed throughout, lagged behind around the far turn and showed little. A STEWARDS' INQUIRY REVIEWING THE START RESULTED IN NO CHANGE

TO THE ORIGINAL ORDER OF FINISH.
