RYVIT dueled early along the inside, allowed the other speed to clear just before a quarter, idled after moving off the rail for the turn, asked into lane, rebid from the outside with a furlong run, gained the advantage then held the runner up safe late under firm handling. TEJANO TWIST last to leave, trailed in the early going well off the inside, began to advance three wide midway on the turn, continued a mild gain while widest down the stretch, not enough in the late going. NORMANDY COAST dueled early outside the winner, cleared toward the inside turn, continued to lead upper stretch, responded when that same rival challenged approaching the furlong grounds, yielded to that rival and the runner up the final furlong. GHOST OF MIDNIGHT one paced while racing off the inside, lacked a closing punch. HEALING WATERS finished early, reported home well back.
