BRILLIANT MAN chased in the four path, improved between foes in the three path around the far turn, swung from the six path into the lane, and rallied past an inner foe late. PROMISSIONE rated in the three path, moved up under a ride around the far turn, kicked on to take command entering the final furlong, but was caught by the outer winner late. HEAVENLY DEACON was unhurried in the two path, advanced between rivals around the far turn, flattened in the final furlong, but got the show photo. TARPS STORM raced in midpack in the four path, was driven in the five path around the far turn, but made no final

bid. PHENOMENAL DREAM settled towards the back of the pack in the two path, was ridden around the far turn, and passed tired foes. WOODSPOINT vied for the lead in the four path, took command passing the half, opened up in the two path around the far turn, but gave way from the three path in the stretch. CHARLEY PRIDE had a slow start, was wellback in the four path and made no impact. CAVANAL led the chasing pack from along the inside but did not factor. MISSING ROCKS tracked out in the five path, was driven from the three path around the far turn, but retreated. FAST JOKER rated in the five path but never threatened. SNEAKY FEET trailed in the five path early and never menaced. SKIBIDI RIZZ dueled for the lead in the two path but lost ground passing the half and gave way around the far turn.
