Weights: 122 lbs. Non-winners of \$50,000 twice allowed 3 lbs.; \$50,000 once 5 lbs. (Maiden and Claiming races not considered in allowances). In Allowance Stakes starting preference will be given to horses that have accumulated the highest earnings. Starters to be named through the entry box by the usual time of closing. The Owner of the winner to receive a trophy. Closed Saturday, January 31, 2025 with 26 nominations.

FRENCH FRICTION dueled for the early lead with an outer foe from the two path, inched away confidently around the turn, was coaxed passing the quarter, and kicked away impressively under light handling. HAVE FAITH rated inside, was cued midway around the turn, cut the corner at the top of the stretch, angled out to the four path, could not keep up with the winner, but kept on while on the left lead to be second best. PAVING raced off the pace in the two path, was ridden around the turn, got stymied from three path at the top of the lane, but finished evenly for show. LITTLE MISS CURLIN stalked in the four path, was ridden outside of the leading duo around the turn, but faded in the six path down the stretch. WAKUDA trailed in the three path, was roused from the two path midway around the turn, but made no closing bid. WOODSTOCK chased between foes in the three path, was driven around the turn, but weakened. EVOLUTION dueled with the inner winner from the three path, was asked for more run midway around the turn, but gave way on the left lead from the five path down the lane. REVERA chased in the five path but did not threaten. GLAZIN' FURY raced in midpack outside of foes from the five path but retreated.
