QUASI WARRIOR pressed the early pace setter three wide, took charge after half, held under steady encouragement. SILHOUTTE COVE set a pressured pace between runners, gave way to QUASI WARRIOR after the half mile marker, chased that foe through the far turn and stretch. MR. RIPPLE tracked the pace from the three path, finished evenly. KISSTHEMOON settled off the pace, began to advance after the first turn but got in tight between runners, chased through the far turn and tipped out to the four path in the upper stretch but could not rally. FOXY JUNIOR raced off the pace, never threatened. EASTER BET pressed the early pace setter from along the inside, began backing off after the first turn to trail by the half mile marker.
