DECREE AND DECLARE bumped with an outer foe at the start, was carried out by DIVULGE soon after, prompted four wide outside that rival heading to the turn, came under a ride dueling past the quarter pole, was brushed and herded out soon into the lane, battled on near even terms and under right handed encouragement near mid stretch, continued on doggedly under a strong hand ride inside the sixteenth pole, wrested command soon after and dug in to prove best. DIVULGE wandered outward bothering foes soon after the break, corrected and set a pressured pace in about three path, worked closer to the inner rail while hounded around the turn, drifted out exchanging contact with the winner in upper stretch, sparred in close proximity the rest of the way and just missed in a valiant effort. GWEN TO WIN , bumped at the break, was carried out soon after and brushed with LET'EM HATE, regrouped and chased off the inside but lacked a serious stretch response. LET'EM HATE was forced out and put in close causing her rider to briefly lose balance and the left iron, recovered and dropped inside, made a run nearing the half, pursued to upper stretch then weakened. Following a stewards' inquiry into the start and stretch run and also an objection by the rider of LET'EM HATE, DIVULGE was disqualified from second and placed fourth for causing interference soon after the the break.
