SPAN OF CONTROL unhurried early to race near the rear of the field, commenced a rally midway on the turn, circled six wide and closed well on the outside to be up in the nick of time. VINSANITY pressed the pace from four wide through the turn, rallied to the lead in upper stretch and wa nailed in the final stride. MR. BONES prompt the pace from the inside to the turn, rallied up the fence to take the lead midway on the turn, was overhauled nearing the eighth pole and kept-on fighting to be denied late in a good effort. LOUISIANIMAL tracked the leaders from four wide to the three-eighths pole, angled in on the bend, made a timid bid up the rail while facing tight quarters at the three-sixteenths pole and finished evenly failing to get through on the fence. CAMILO failed to menace going evenly. MAYHEMINTHEPALACE trailed most of th way and never posed a threat. CHIPS LEGACY showed speed dueling on the lead to midway on the turn and tired late in the drive. THE RIDER OF LOUISIANIMAL CLAIMED FOUL FOR INTERFERENCE IN THE STRETCH BY MR. BONES, UPON REVIEW THE STEWARDS MADE NO CHANGE.
