ON RESERVE broke mid-pack, settled in hand to race at the rear of the field into the turn, saved ground on the bend, cut the corner turning for home, waited for the pacesetter to drift out from the inside and surged up the rail to be clear late. BLAST OF MISCHIEF set the pace under steady pressure to the top of the lane, opened a clear lead while drifting out in upper-stretch and was outkicked in the final sixteenth. SWEET CAROL JAMES tracked the leaders to midway on the turn, was put to a drive early to make a steady rally, was fanned eight wide at the head of the stretch and mounted a grinding rally down the lane. KNICKS FACTOR stalked the pace through the turn and put in a mild bid in the lane to hit the board. SERENE WATERS rated in mid-pack down the backstretch, closed the gap on the bend and flattened out coming home. FLOYNESS was not a threat. SPOKEN VOW pressed the pace to the quarter pole and gave way.
