VALIANT ENYA unhurried in the early going, narrowed the gap on the turn while saving ground, angled four wide in upper stretch to the clear and made a determined rally to wear the pacesetter down late. MOMENTOUS MISS set a pressured pace to the top of the lane, repelled the challengers in upper stretch, dueled with the winner in the final eighth and was outfinished late in a game effort. MAKE A MILLION stalked the pace through the turn to be well placed, mounted a mild bid turning for home and came home evenly. HAUT LES COEURS pressed the pace from the inside to the quarter pole and lacked a closing kick when called upon. JAZZ TIME GIRL tracked the leaders from between rivals to midway on the turn and went evenly failing to menace. KAGERO trailed never posing a threat.
