CHRIS'S KITTY pressed the pace from three wide to midway on the turn, rallied to engage the leader at the quarter pole, took command in upper stretch and pulled clear down the lane. BUCCHINI tracked the pacesetters to the five-sixteenths pole, rallied four wide to threaten turning for home, failed to gain on the winner while finishing willingly on the wrong lead. SENSIBLE MARRIAGE set a pressured pace to the head of the stretch and gradually weakened through the lane while holding the show. COUNTRY MANOR chased the pace from five wide and lacked a closing kick. CHEERFUL TROUT trailed most of the way failing to pose a threat.
