A CASE OF YOU reserved off the pace along the fence in the tightly bunched field, waited behind rivals on the turn, angled five wide turning for home forcing his way through, quickly went clear in hand a no doubt winner. LOUISE BROOKS rated at the rear of the compact field, circled the pack turning for home and closed well to gain the place. LITTLE LAMB CHOP stalked the pace from three wide through the turn, rallied in upper stretch to take a brief lead and was outfinished through the drive. GENEVIEVE'S Z VA pressed the pace to the quarter pole to be prominently placed and ran-on in the lane unable to keep pace with the winner. CLOUD IN THE WIND set a pressured pace to the top ofthe lane, battled to mid-stretch and weakened in the final furlong.
