SIPPING FIREWATER sped to the lead at the start, set the early pace, vied around the turn, shook free under mild urging and widened with ease. KANJENG was forwardly placed, vied around the turn, was no match with eventual winner past the top of the stretch, ran on and finished clearly second best. GISELE'S MAP tracked along the inside, coaxed around the turn, kept under a ride into the stretch run and ran on for a share. STELLA BELLA sat midpack in early stages, advanced to sit just off the top pair around the turn, ran on into the stretch then gave way in the final furlong. TOMMY'S CRUE was not far back early on, coaxed three wide around the turn, kept under a ride into the lane and failed to pose a threat. MORNINGNOONANDNITE raced in the back, hustled along four then three wide in the upper stretch and lacked a needed rally. DREAMINONTHENILE raced in range between foes in early stages, weakened out of flight, failed to advance around the turn and steadily faded. ADDABABY raced near midpack, chased two wide around the turn then retreated.
