FOR FILLIES & MARES, THREE-YEAR-OLDS & UPWARD. Weights: Three-Year-Olds 120 lbs.; Older - 126 lbs. Non-winners of \$60,000 at a mile or over in 2025-2026 allowed 2 lbs.; non-winners of \$45,000 at a mile or over in 2025-2026 allowed 4 lbs.; \$30,000 at a mile or over in 2025-2026 allowed 6 lbs. (Maiden and claiming races not considered) No nomination fee. \$250 to pass the entry box and \$250 additional to start. \$50,000 guaranteed which will first be reduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% to sixth. SUPPLEMENTAL NOMINATIONS AT TIME OF ENTRY WITH A FEE OF \$750 TO ENTER AND START. Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceed fourteen (14), high weights will be preferred, then highest 2025-2026 earnings at closing time of entries. Different owners will have equal draw according to weights. The second parts of same owner entries will have no consideration over a single interest. Failure to draw into race cancels all fees. Closed Saturday, May 30, 2026 with 18 nominations.

IN JUST MY HEELS broke on top and held a slim lead around the first turn, led the way under some pressure but remained nicely settled on top, came under a ride approaching the mid-way point on the far turn, quickly widened advantage, saved ground turning for home, responded willingly under steady encouragement and drew off to an easy score. FULL SPIRIT prompted the pace two wide in early stages, hustled along two wide going by the five sixteenths pole, was forced into the path of POPPERINA when STARWOOD drifted into path leaving the far turn, ran on gamely dueling for place and nipped foe for position on the wire. STARWOOD was forwardly placed around the first turn, stalked the top pair up the backstretch, came under right handed pressure three wide leaving the three eighths pole, drifted into the path of FULL SPIRIT who was forced into the path of rail running POPPERINA leaving the turn, ran on two wide down the lane and got nipped for place. POPPERINA tracked the pace in early stages, went to make a move along the rail at the quarter pole, lost path when STARWOOD forced FULL SPIRIT to the inside, steadied sharply, lost all momentum, shifted out wider in upper stretch but failed to move on. KANOJO reared and lost rider at the start, ran loose then corralled by outriders and walked off. THE STEWARDS POSTED INQUIRY AND TEH JOCKEY OF POPPERINA CLAIMED FOUR AGAINST STARWOOD FOR INTERFERENCE LEAVING THE FAR TURN, AFTER REVIEW STEWARDS FOUND STARWOOD GUILTY OF INTERFERENCE AND WAS DISQUALIFIED FROM THIRD TO FOURTH
