PALACE GUARD was unhurried through early stages, shifted out turning for home and bumped into KOBE'S CAUSE, sustained a steady bid and cleared the lead just past the sixteenth pole. KOBE'S CAUSE settled off the clear top trio in the opening quarter, took closer order late on the turn, got bumped into by PALACE GUARD entering the head of the lane, ran on evenly to the furlong marker then edged closer late. CASA LIMON vied three wide up the backstretch, shook free past the quarter pole, continued to lead the way under firm handling a furlong out then got overtaken late. RUN FOR GOLD dueled between foes in the opening quarter, battled inside of CASA LIMON around the turn then came up empty a furlong out. ROCKIN THE DAD BOD raced off the pace, hustled along three to four wide into the lane and had no response. REDNECKERTHANYOU vied inside a duo up the backstretch, could not match strides approaching the mid-way point around the turn and tired in the drive. STEWARDS POTED INQUIRY AND THE RIDER OF KOBE'S CAUSE CLAIMED FOUL AGAINST PALACE GUARD FOR INTERFERENCE AT THE HEAD OF THE LANE, AFTER REVIEW THE ORDER STOOD AS POSTED
