DAY BOSS tracked the leader up the backstretch, headed in pursuit rounding out the turn, challenged BRASA for the lead, vied outside of rival in upper stretch, came under right handed pressure, drifted in, bumped BRASA and battled on. BRASA sped to the lead at the start and set the early pace, held clear around the turn then took on the challenge of DAY BOSS at the head of the lane, dueled inside of rival holding a slight edge then raced heads apart, got bumped by rival near mid-stretch and ran on. WAGON POWER sat off the top trio in the opening quarter, was ridden four wide late on the turn, sustained a steady outside bid down the lane and cleared show. BIG FURN was forwardly placed up the backstretch, ran on evenly inside around the turn, came three wide into upper stretch and gave way. SOMBRADENOCH failed to move into contention. ULTRA MIKE showed little. THE JOCKEY OF BRASA CLAIMED FOUL AGAINST DAY BOSS FOR INTERFERENCE IN THE STRETCH, AFTER REVIEW DAY BOSS WAS DISQUALIFIED FROM FIRST AND PLACED SECOND
