(Maiden and claiming races not considered) No nomination fee. \$500 to pass the entry box and \$1,000 additional to start. ENTRY AND START FEES WILL BE WAIVED FOR ANY HORSE THAT HAS WON A GRADED STAKE IN 2026. \$100,000 guaranteed which will first bereduced so as to allow \$500 to be paid to each of the seventh through last place finishers with the remaining purse paid out as follows: 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth, 2% to sixth. SUPPLEMENTAL NOMMINATIONS AT TIME OF ENTRY WITH A FEE OF \$2,000 TO ENTER AND START. Starters to be named through the entry box by the usual time of closing. Should this race not be divided and the entry number exceeds twelve (12), high weights will be preferred, then highest 2025-2026 earnings. Different owners will have equal draw according to weights. Failure to draw into the race cancels all fees. Closed Saturday, June 27, 2026 with 32 nominations.

PARADISE CITY tracked in contention along the inside, sat patiently waiting for a clear path around the turn, cut the corner entering the head of the lane, slipped through along the inside of SILENT LAW, dug in gamely, took command past mid-stretch and finished clear. SILENT LAW broke sharp, cleared and crossed over to the inside, set the early pace and held clear around the turn, came two wide into the head of the lane, took on the rail challenge of PARADISE CITY, fought back past the furlong marker but could not move on late. JUSTINQUESO raced in range up the backstretch, given cue three wide at the head of the lane, could not reach the top two finishers but sustained a solid bid and cleared the rest. BLUE SQUALL raced in the back, swung four wide into the lane and had no response. ERVADEAN was forwardly placed, continued in contention around the turn then retreated.
