SIC' EM' SIS dueled between foes in early stages, battled on inside of TIMEFORWHAT into the stretch run, brushed with rival, dug in gamely from the inside and edged clear. TIMEFORWHAT vied three deep in early stages, continued to battle for command racing outside of SIC EM SIS into the lane, brushed with rival, fought gamely but got denied in final stages. CHIRPY CHICKS got bumped at the start and raced well off the early pace, hustled along four wide into the upper stretch and gained show. INTERCONNECT broke out and bumped with rival at the start, raced in the second flight going past the half mile marker, saved ground around the turn, angled two to three wide in upper stretch and lacked late kick. SUGAH DOWN dueled inside of a duo in opening stages, battled on around the turn then tired in the drive. CARME took a solid bump at the start, raced in the second flight late on the backstretch, flattened around the turn and continued to weaken in the lane. CLOUDY ONE failed to move into contention. JOCKEY OF TIMEFORWHAT CLAIMED FOUL AGAINST SIC EM SIS FOR INTERFERENCE IN THE STRETCH, AFTER REVIEW NO ACTION WAS TAKEN
